Programme Title	Additional Requirement
All programmes	Continuation on the programme is subject to specific health requirements (consistent with the provisions of the Equality Act 2010). Candidates are required to inform the Faculty of any health problems throughout their period of enrolment, relevant to their future employment as a professional.
All programmes	A candidate will be deemed to have failed the programme, without the right of re-entry, in exceptional circumstances where there is gross misconduct or a serious breach of the Code of Conduct of the British Psychological Society.
All programmes	A candidate will be deemed to have failed the programme, without the right of re-entry, if they have failed to complete all elements of summative assessment to a satisfactory standard within 5 years of first registration, or by such a date as will have been agreed by the Board of Examiners.

These regulations should be read in conjunction with the programme specification.
